ITEM 5.02 Departure of Directors or Certain Officers; Election of Directors; Appointment of Certain Officers; Compensatory Arrangements with Certain Officers

On March 29, 2017, Fidelity D & D Bancorp, Inc. (the “Company”) and its wholly owned subsidiary Fidelity Deposit and Discount Bank (the “Bank”) entered into a change in control and severance agreement with Michael J. Pacyna, Jr., Executive Vice President and Chief Business Development Officer of the Bank.

The material terms of Mr. Pacyna’s change in control and severance agreement are as follows:

1. The term of the agreement begins March 29, 2017 and continues until any party gives notice of termination of employment for any reason, unless an agreement to effect a “Change in Control”, as defined in the agreement, has been executed, and then the agreement only terminates if the executive is terminated for “Cause”, as defined in the agreement.
2. If the executive is terminated or certain other changes in employment occur, as identified in the agreement, after a “Change in Control”, the executive shall be entitled to receive a lump sum equal to one (1) times his annual base salary and continuation of all life, disability, medical insurance and other normal health and welfare benefits for one (1) year.
3. If the executive is terminated without cause and no change of control occurs, he shall be entitled to receive a lump sum equal to six (6) months of this annual base salary and continuation of all life, disability, medical insurance and other normal health and welfare benefits for six (6) months.
4. The agreement contains certain customary confidentiality and non-competition provisions.

The description above is only a summary of the material terms of Mr. Pacyna’s agreement and is not intended to be a full description of the agreement. The agreement is attached hereto as Exhibit 99.1 and is incorporated herein by reference.
