Item 8.01. Other Events.

On May 18, 2011, The Walt Disney Company (the "Company") entered into a Terms Agreement with Citigroup Global Markets Inc., Merrill Lynch, Pierce, Fenner & Smith Incorporated and RBS Securities Inc., as representatives of the several underwriters named therein, with respect to the offer and sale of \$500,000,000 aggregate principal amount of its 3.750% Global Notes Due 2021 (the "Notes"). The Notes were offered to the public at 99.933% of par and proceeds to the Company net of underwriting discounts and commissions of 0.450%, before expenses, was 99.483% of par. The Notes were registered under the Securities Act of 1933, as amended, pursuant to the shelf registration statement on Form S-3 (File No. 333-171048) of the Company. The Notes are being issued pursuant to a Senior Debt Securities Indenture, dated as of September 24, 2001, between the Company and Wells Fargo Bank, National Association, as trustee.
