The Company is disclosing to investors in the private investment funds that it manages that, as of December 1, 2013, the estimated unaudited amount of assets under management was approximately \$9.3 billion, which reflects a net decrease of approximately \$0.1 billion since November 1, 2013. The Company's estimate of assets under management is inclusive of performance for the month ended November 30, 2013 and capital flows as of December 1, 2013.

We do not possess unilateral control over any of these general partners or managing members.

(b) Includes approximately \$225 million of committed but undrawn capital that will only be charged fees when invested.

(c) These amounts include the Company's invested capital of approximately \$100.1 million and \$101.1 million as of December 1, 2013, and November 1, 2013, respectively.
