- (2) Represents pro-rata portion of additional shares of common stock of the Issuer that were earned on market stock units granted in December 2011 in addition to the 26,605 target shares reported on December 6, 2011. These additional shares were earned based upon the Issuer's financial performance over fiscal years 2012-2014 and include 1,931 shares representing dividend equivalent rights accrued to the reporting person on the additional shares in connection with the Issuer's quarterly dividends from the second quarter 2013 through the fourth quarter 2014.
