Alicia Moreau de Justo 50, City of Buenos Aires, in order to inform you that on Monday, March 4, 2019, the Company entered into a loan agreement with the <i>International Finance Corporation</i> ( IFC ), for a total amount of up to US\$ 450,000,000 as requested by the Company in one or more disbursements (the <b>Loan</b> ). The proceeds from the loan will be used by the Company to finance the Company s capital investments for 2019.
The Loan will consist of a tranche A ( <b>Tranche A</b> ), tranche B-1 ( <b>Tranche B-1</b> ), tranche B-2 ( <b>Tranche B-2</b> ), tranche B-3 ( <b>Tranche I</b> tranche B-4 ( <b>Tranche B-4</b> ). In addition, the amounts disbursed under the Loan will mature in August 2023, in the case of Tranche B-1 and Tranche B-3, or in August 2024, in the case of Tranche A, Tranche B-2 and Tranche B-4.
