(1) This amendment adds the following three footnotes that were inadvertently omitted from the original filing.

Ms. Taylor also holds an additional 127,419 vested stock options, 54,167 unvested stock options, and 10,026 target performance shares (the exact number awarded being dependent on achievement of performance goals).
