- (1) Shares of restricted stock granted on June 16, 2008 under Mariner Energy, Inc. Second Amended and Restated Stock Incentive Plan as part of 2008 Long-Term Performance-Based Restricted Stock Program. The stock generally vests as follows: (i) 40% of the shares vest pro rata over five years on each of the first five anniversaries of the date on which the rolling 15-day average closing price per share of Mariner common stock is \$38 or more but less than \$46, and (ii) the remaining 60% of the shares vest pro rata over seven years on each of the first seven anniversaries of the date on which the rolling 15-day average closing price per share of Mariner common stock is \$46 or more.
