As a result of the anti-dilution adjustments, the amount of beneficial ownership shown for the reporting person reflects an increase of 3,685 units subject to the reporting person's previously reported restricted stock unit award granted on December 20, 2010. All other terms and conditions governing such award remained unchanged.
