The principal cause of our failure to timely file our Quarterly Report on Form 10-QSB for the period ended November 30, 2003, is that the person responsible for preparing the report and related financial statements has also been responsible for undertaking all steps necessary to defend the company's remaining assets against substantial litigation practices of the company's former bank including the preparation of legal documents and attendance at various court hearings and to negotiate the potential acquisition of a new business. As a result of these disruptions, additional time is required to compile and present the unaudited financial statements to the Registrant's auditors and we were unable to complete the preparation of the Quarterly Report on Form 10-QSB in time for the January 14, 2004 deadline without unreasonable effort or expense.
