Item 5.07. Submission of Matters to a Vote of Security Holders.

On May 7, 2013, the Company held its Annual Meeting of Stockholders, at which the stockholders approved the following proposals: (1) the re-election of Gillon Beck and Dan Falk to the Board of Directors for new terms of three years each, and (2) ratification of the appointment of PricewaterhouseCoopers LLP to act as the Company's independent auditor for fiscal year ending December 31, 2013.
