- (1) Each restricted stock unit represents a contingent right to receive one share of HP common stock.  
 As previously reported, on 11/01/10 the reporting person was granted 45,000 restricted stock units ("RSUs"), 15,000 of which will vest on 11/01/11, and 30,000 of which will vest on 11/01/13. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The 172,608 dividend equivalent rights being reported reflect 85,186 dividend equivalent rights at \$42.26 per RSU credited to the reporting person's account on 12/30/10 and 87,421 dividend equivalent rights at \$41.18 per RSU credited to the reporting person's account on 04/06/11.
- (3) On 04/25/11 the reporting person was granted 6,786 restricted stock units ("RSUs"), all of which will cliff vest on 04/25/12. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock.
