The shares vest in three annual installments, beginning two years from date of grant. The shares were awarded under the terms of

- (1) Questar's Long-term Stock Incentive Plan; 3,334 vest on or about February 8, 2007; 3,333 on or about February 8, 2008; and 3,333 on or about February 8, 2009.
- (2) As of February 7, 2005, I have 1,196.6685 equivalent shares of stock in Questar's Employee Investment Plan. The number of equivalent shares will fluctuate as Questar's stock price changes; this fluctuation does not reflect any transactions that should be reported.
- (3) The question about dates is irrelevant since I am not reporting any changes in my stock options.
- (4) This date has not been filled in since I am not reporting any changes in my phantom stock units.
- (5) I receive phantom stock units as a result of my participation in an excess benefit Plan. This total includes 10,114.1537 units in such plan, in addition to units held through my account balance in a deferred compensation plan.
