Mr. Gillespie's interest is limited to that as the principal of the general partner of each of Prospector and Prospector Small Cap and as principal of the investment manager of Prospector Offshore.

(2) Since March 26, 2004, the date of Reporting Person's last filing, Reporting Person acquired 4 shares of WTM's Common Shares under the OneBeacon Employee Stock Ownership Plan. WTM Common Shares are purchased at fair market value on the date of purchase. The information in this report is based on a plan statement dated as of March 10, 2005.

(3) Phantom Shares are convertible into Common Shares on a 1 for 1 basis.

(4) On March 23, 2005, the Reporting Person's deferred compensation account was credited with Phantom Shares equal in value to the ordinary dividend paid on the underlying WTM Common Shares on the dividend date.

(5) The Phantom Shares are payable, at the election of the Company, in cash or in Common Shares following termination of the Reporting Person's employment with the Company or beginning at an earlier date selected by the Reporting Person in accordance with the terms of the deferred compensation plan.

(6) Dividends are automatically invested in Phantom Shares at the fair market price per share of the underlying WTM Common Shares on March 23, 2005, the date the dividends are deemed to be paid.
