The restricted stock vests over time at 10%, 20%, 30% and 40%, respectively, on each anniversary of February 23 for the years 2007 through 2010 ("Time Vesting"). If and when the Company's common stock closes at or above per share target prices of \$35.52, \$40.85 and \$46.98, 33% of the restricted stock performance vests ("Performance Vesting").
- (2) The stock is restricted stock issued pursuant to the Company's 2004 Stock Incentive Plan. Such restricted stock vests on February 23, 2009, subject to forfeiture in the event the Reporting Person terminates employment prior to such time.
