(4) A total of 13,000 restricted stock units were originally awarded on March 21, 2007 of which 6,500 units have vested and converted into an equal number of shares of common stock. Pursuant to the terms of the Executive Officers' Change of Control Incentive and Severance Benefit Plan, as amended, 3,250 units vested and shares became issuable on July 10, 2009 upon a change of control. The remaining units shall vest and shares become issuable on March 21, 2010.

(5) Not applicable.

(6) A total of 13,300 restricted stock units were originally awarded on March 24, 2008 of which 3,325 units have vested and converted into an equal number of shares of common stock. Pursuant to the terms of the Executive Officers' Change of Control Incentive and Severance Benefit Plan, as amended, 3,325 units vested and shares became issuable on July 10, 2009 upon a change of control. The remaining units shall vest and shares become issuable in two equal annual installments beginning on March 24, 2010.

(7) A total of 90,000 restricted stock units were originally awarded on March 20, 2009. Pursuant to the terms of the Executive Officers' Change of Control Incentive and Severance Benefit Plan, as amended, 29,997 units vested and shares became issuable on July 10, 2009 upon a change of control. The remaining units shall vest and shares become issuable in two equal annual installments beginning on March 20, 2010.

(8) As of July 10, 2009, the reporting person owned approximately 17,293 units, which units represent interests in a Wind River 401(k) Plan. As of July 10, 2009, those units equate to approximately 5,519 shares of Wind River common stock at the closing price of Wind River common stock on July 10, 2009 of \$11.50.
