**Item 7.01. Regulation FD Disclosure**

On November 15, 2010, Casey's General Stores, Inc. (the "Company") reported October 2010 same-store sales results for stores open for one full year. Same-store sales for prepared food and fountain increased 10.5%, and grocery and other merchandise increased 13.4% in October 2010 compared to October 2009.

Same-store gasoline gallons sold increased 4.0% in October 2010 compared to October 2009. The gasoline margin was in line with the Company's fiscal 2011 goal of 13.5 cents per gallon. The average retail price of gasoline sold during October 2010 was \$2.68 per gallon.
