 1,644 of the 3,287 shares granted to the Reporting Person under the Issuer's 1997 Stock Plan were vested and released to the Reporting Person effective May 10, 2012. Such 3,287 shares vest at the following rate: 1/4th of such shares vest on May 14, 2010 and on each one (2) year anniversary thereafter, and in each case subject to the satisfaction of certain performance criteria. It was determined that May 10, 2012 was the date on which vesting of 50% of the original 3,287 share grant was deemed to have occurred pursuant to the satisfaction of certain performance criteria.
