- (1) Annual grant to non-employee directors of restricted stock units that convert to Phillips 66 common stock on a 1-for-1 basis. The restrictions on the RSUs lapse on the retirement, disability or death of the non-employee director.
- (2) Includes shares acquired through routine dividend transactions that are exempt under rule 16a-1.

- (3) These RSUs were granted by ConocoPhillips as compensation for Mr. McGraw's service on the board of ConocoPhillips. The RSUs were divided upon the spin-off of Phillips 66 into RSUs related to both Phillips 66 common stock and ConocoPhillips common stock at a ratio intended to generally preserve the intrinsic value of each RSU immediately prior to the spin-off.
