(1) These shares were awarded on February 7, 2011 as Time-Based Restricted Stock Units. As reported in the Issuer's Form 8-K filed on April 19, 2012, the Time-Based Restricted Stock Units were converted to Performance-Based Restricted Stock Units on April 19, 2012 by adding certain performance-related vesting conditions in addition to the time-based vesting conditions. These performance-related vesting conditions (but not time-based vesting conditions) were satisfied on January 21, 2014. This filing reflects that the performance-related vesting conditions have been satisfied and the Performance-Based Restricted Stock Units remain subject only to time-based vesting conditions. The time-based vesting conditions will be met and these units will fully vest on February 7, 2014, subject to the Reporting Person's employment with the Issuer on that date and in accordance with the terms and conditions of the applicable award agreement
