 Represents the vesting and payout of the first tranche (1/3) of the leveraged restricted stock units granted on March 1, 2013 at 139.1% based on the issuer's stock price performance during the performance period from 1/1/2013-12/31/2013 and includes 644 additional shares above the target number of shares originally reported.
