Relevant Securities in Issue

ScottishPower announces, in accordance with Rule 2.10 of the City Code on Takeovers and Mergers, 18 January 2007 it had the following securities in issue:

Ordinary share capital 1,488,573,888 shares of 42p each ("ordinary shares").

The ISIN reference number for these securities is GB00B125RK88.

US\$ perpetual subordinated convertible bonds US\$700 million in aggregate ("convertible bonds"). These securities are XS0171162075 (Reg S) and XS0171196727 (144a).

Dealing Disclosure Requirements

Under the provisions of Rule 8.3 of the Takeover Code (the "Code"), if any person is, or becomes indirectly) in 1% or more of any class of "relevant securities" of ScottishPower, all "dealings" in such securities by that person or company (including by means of an option in respect of, or a derivative referenced to, any such securities) which are publicly disclosed by no later than 3.30pm (London time) on the London business day following the date of such disclosure. This requirement will continue until the date on which the offer becomes, or is declared, unconditional, or is otherwise withdrawn or on which the "offer period" otherwise ends. If two or more persons act in concert, or in understanding, whether formal or informal, to acquire an "interest" in "relevant" securities" of ScottishPower, they shall be treated as a single person for the purpose of Rule 8.3.

Under the provision of Rule 8.1 of the Code, all "dealings" in "relevant securities" of ScottishPower by any person or "associates", must be disclosed by no later than 12.00 noon (London time) on the London business day following the date of the relevant transaction.

"Interests in securities" arise, in summary, when a person has long economic exposure, whether or not

the price of securities. In particular, a person will be treated as having an "interest" by virtue of securities, or by virtue of any option in respect of, or derivative referenced to securities.

Terms in quotation marks are defined in the Code, which can also be found on the Panel's website. whether or not you are required to disclose a "dealing" under Rule 8, you should consult the Panel's website.
