Unilever NV announces that on 28 June 2007 it purchased 310,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 22.830 and euro 23.160 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 66,432 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 76,810,925 Unilever NV ordinary shares in treasury, and has 1,637,916,775 Unilever NV ordinary shares in issue (excluding treasury shares).
