Unilever NV announces that on 3 September 2007 it purchased 331,744 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 22.300 and euro 22.440 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 20,683 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 90,651,379 Unilever NV ordinary shares in treasury, and has 1,624,076,321 Unilever NV ordinary shares in issue (excluding treasury shares).
