Unilever NV announces that on 21 April 2008 it purchased 425,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 21.140 and euro 21.530 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 13,585 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 154,857,201 Unilever NV ordinary shares in treasury, and has 1,559,870,499 Unilever NV ordinary shares in issue (excluding treasury shares).
