Net loss for the three months ended September 30, 2005 is expected to be approximately \$612,000 as compared with approximately \$1,005,000 for the three months ended September 30, 2004. Underlying these results are expected operating expenses of approximately \$1,244,000 for the three months ended September 30, 2005, as compared to approximately \$1,851,000 for the three months ended September 30, 2004.

The Registrant expects to report net revenues of approximately \$4,734,000 for the nine months ended September 30, 2005, as compared to approximately \$6,555,000 for the nine months ended September 30, 2004. Net loss for the nine months ended September 30, 2005 is expected to

be approximately \$1,809,000 as compared with approximately \$2,123,000 for the nine months ended September 30, 2004. Underlying these results are expected operating expenses of approximately \$4,221,000 for the nine months ended September 30, 2005 as compared to approximately \$5,763,000 for the nine months ended September 30, 2004.
