<b>Net proceeds to Chesapeake Energy Corporation, after underwriters discount, but before other offering expenses:</b>	\$787,000,000
<b>Use of proceeds:</b>	We intend to use the net proceeds from this offering, together with the net proceeds from our pending public offering of Contingent Convertible Notes, to fund the redemption of our 7.75% Senior Notes due 2015, to temporarily repay indebtedness outstanding under our revolving bank credit facility and for general corporate purposes.
<b>Concurrent Offering:</b>	On May 19, 2008, we commenced a separate public offering of \$500 million in aggregate principal amount of Contingent Convertible Notes due 2038. The aggregate principal amount of Contingent Convertible Notes due 2038 offered in the separate offering is being increased to up to \$1.2 billion, plus an over-allotment option. The additional proceeds from any such increase will be applied to temporarily repay additional indebtedness outstanding under our revolving bank credit facility. Neither this offering, nor the offering of Contingent Convertible Notes, is contingent on the other.
