On September 11, 2008, Host Hotels & Resorts, Inc. (Host) announced that Host Hotels & Resorts, L.P. (Host LP), for whom Host acts as sole general partner, has entered into an agreement through its 32.1% owned joint venture in the Netherlands to purchase six hotels in three European countries for approximately 565 million, which includes the assumption of debt totaling approximately 434 million. A copy of the press release is furnished as Exhibit 99.1 to the Report.
