*Credit Agreement Amendment*

On December 31, 2008, Bank of America, N.A. and KVH Industries, Inc. (the Company ) amended the maturity date of the Amended and Restated Credit Security Agreement, dated July 17, 2003, providing for a \$15,000,000 line of credit (the Line ) to the Company from December 31, 2008 to December 31, 2011.
