Item 3.02 Unregistered Sales of Equity Securities.

As of March 10, 2010, DexCom, Inc. ("DexCom") entered into agreements with holders of DexCom's issued and outstanding 4.75% Convertible Senior Notes due 2027 (the "Notes"), under which DexCom agreed to issue an aggregate of 1,480,404 shares of its common stock, par value \$0.001 per share, in exchange for \$11,150,000 in aggregate principal amount of the Notes held by the exchanging holders. No commission or other remuneration was paid or given directly or indirectly in connection with the exchange. The exchange is exempt from registration under Section 3(a)(9) of the Securities Act of 1933, as amended.
