\* EDB Investments Pte Ltd ( EDB Investments ) is the parent entity of Biomedical Sciences Investment Fund Pte Ltd. The Economic Development Board of Singapore ( EDB ) is the parent entity of EDB Investments. EDB is a Singapore government entity. EDB Investments, EDB and the Singapore government may be deemed to have shared voting and dispositive power over the shares owned beneficially and of record by Biomedical Sciences Investment Fund Pte Ltd.

On April 22, 2010, Biomedical Sciences Investment Fund Pte Ltd acquired 3,358,522 shares of common stock of Codexis, Inc. in connection with the initial public offering of Codexis, Inc. upon the conversion of preferred stock. Immediately following the initial public offering, Biomedical Sciences Investment Fund Pte Ltd beneficially owned 3,358,522 shares with shared voting and dispositive power. On December 20, 2010, Biomedical Sciences Investment Fund Pte Ltd sold 100,000 shares of the common stock of Codexis, Inc. As of December 31, 2010, Biomedical Sciences Investment Fund Pte Ltd beneficially owned 3,258,522 shares of the common stock of Codexis, Inc. with shared voting and dispositive power, or 9.4% of the total outstanding common stock of Codexis, Inc. In 2011, Biomedical Sciences Investment Fund Pte Ltd sold an aggregate of 100,000 shares of the common stock of Codexis, Inc.
