This Amendment No. 7 (this Amendment No. 7 ) amends a Statement on Schedule 13D filed on February 16, 2007 on behalf of the reporting persons named therein with the United States Securities and Exchange Commission, as amended on February 11, 2008, February 17, 2009, September 8, 2009, February 1, 2010, December 2, 2010 and June 14, 2013 (as amended, the Schedule 13D ). This Amendment No. 7 is being filed to reflect that the reporting persons combined beneficial ownership of the Issuer s outstanding Ordinary Shares fell below 5% as of January 14, 2014. Capitalized terms used but not otherwise defined herein shall have the meanings prescribed to them in the Schedule 13D.

The Schedule 13D is hereby amended as follows:

#### **ITEM 2. IDENTITY AND BACKGROUND**

Schedule 1, which is incorporated herein by reference and sets forth the name, business address and citizenship of each of the directors of each undersigned reporting person, is amended and restated as set forth in Schedule 1 hereto.

#### **ITEM 5. INTEREST IN SECURITIES OF THE ISSUER**

(a) Based on information provided by the Issuer, there were 32,147,232,938 Ordinary Shares of the Issuer issued and outstanding as of January 21, 2014. As of the date of this Amendment No. 7, S.I. Technology Production Holdings Limited directly holds 1,514,269,340 Ordinary Shares of the Issuer and SIIC Treasury (B.V.I.) Limited no longer directly holds any Ordinary Shares of the Issuer. By virtue of their membership of a group for purposes of the Schedule 13D and this Amendment No. 7, each of the undersigned reporting persons may be deemed to beneficially own such shares totaling 1,514,269,340 Ordinary Shares, which represent approximately 4.71% of the Issuer s outstanding capital stock as of January 21, 2014. Because the reporting persons are no longer the beneficial owners of more than 5% of the Ordinary Shares as of January 14, 2014, no reporting person will be required to file further amendments to the Schedule 13D. If a reporting person becomes the beneficial holder of more than 5% of the Ordinary Shares and is required to file pursuant to Rule 13d-1 promulgated under the Securities Act of 1933, such reporting person will file a new Schedule 13D.

(b) By virtue of their membership of a group for purposes of the Schedule 13D and this Amendment No. 7, the undersigned reporting persons may be deemed to have shared voting power to vote or direct the vote, and dispose or direct the disposition of all 1,514,269,340 Ordinary Shares.

(c) Attached as Schedule 2 hereto, which is incorporated herein by reference, is a description of the transactions in the Ordinary Shares effected by SIIC Treasury (B.V.I.) Limited and S.I. Technology Production Holdings Limited during the 60 days prior to the date of this Amendment No. 7.
