To announce the differences between TSMC's 2013 consolidated financial statements on the basis of Taiwan-IFRSs and IFRSs as issued by the IASB.

- (1) Under International Financial Reporting Standards endorsed by the Financial Supervisory Commission of the Republic of China (Taiwan-IFRSs), Taiwan Semiconductor Manufacturing Company Ltd. (The Company; TSMC) (NYSE:TSM) reported consolidated net income attributable to shareholders of the parent of New Taiwan Dollars (NT\$)188,147 million, basic and diluted earnings per share of NT\$7.26 in 2013, total assets of NT\$1,263,055 million, total liabilities of NT\$415,280 million, noncontrolling interests of NT\$267 million, and equity attributable to shareholders of the parent of NT\$847,508 million as of December 31, 2013.
- (2) For the purpose of filing the annual report on Form 20-F with the U.S. Securities and Exchange Committee, TSMC prepared the consolidated financial statements in accordance with International Financial Reporting Standards (IFRSs) as issued by the International Accounting Standards Board (IASB) and reported consolidated net income attributable to shareholders of the parent of NT\$183,978 million, basic and diluted earnings per share of NT\$7.10 in 2013, total assets of NT\$1,262,801 million, total liabilities of NT\$428,688 million, noncontrolling interest of NT\$267 million, and equity attributable to shareholders of the parent of NT\$833,846 million as of December 31, 2013.
- (3) The major differences between TSMC's 2013 consolidated financial statements on the basis of Taiwan-IFRSs and IFRSs as issued by the IASB were the timing of the recognition of 10% income tax on unappropriated earnings and the accounting for retirement benefit plan.
