Item 1. Security and Issuer

This Schedule 13D relates to the ordinary shares (the <u>Ordinary Shares</u>) of Origin Agritech Limited, a British Virgin Islands company (the <u>Issuer</u>). Item 5. Interest in Securities of the Issuer

(a) (b) As of December 29, 2014, Bonasmart is the record holder of 2,117,445 Ordinary Shares of the Issuer representing approximately 9.3% of the issued and outstanding shares of the Issuer. Mr. Yuan is the beneficial owner of such 2,117,445 Ordinary Shares. The forgoing disclosure assumes that there are a total of 22,738,541 Ordinary Shares outstanding as of June 30, 2014 based on the information provided in the Issuer s earnings release on Form 6-K filed with the Securities and Exchange Commission on August 4, 2014. Excluded in the foregoing number of shares are 45,000 shares underlying options held by Mr. Yuan.
