Linked to a Global ETF Basket comprised of the SPDR® S&P 500® ETF Trust (55%); the iShares® Russell 2000 ETF (15%); the iShares® MSCI EAFE ETF (15%); and the iShares® MSCI Emerging Markets ETF (15%)

o If the value of the Basket decreases by more than 30%:

You will have full downside exposure to the decrease in the value of the Basket from the starting price, and you will lose more than 30%, and possibly all, of the original offering price of your securities

Investors may lose some, or all, of the original offering price

How the redemption amount is calculated

The redemption amount payable at maturity will be determined as follows:

If the ending price is greater than the starting price, the redemption amount will be equal to \$1,000 plus

\$1,000 × ending price starting price starting price x participation rate

If the ending price is less than or equal to the starting price, but greater than or equal to the threshold price, the redemption amount will be equal to \$1,000

If the ending price is less than the threshold price, the redemption amount will be equal to \$1,000 minus

\$1,000 × starting price ending price starting price

If the ending price is less than the threshold price, you will lose more than 30%, and possibly all, of the original offering price of your securities at maturity.

How the ending price is calculated

The ending price will be calculated based on the weighted returns of the basket components and will be equal to the product of (i) 100 and (ii) an amount equal to 1 plus the sum of: (A) 55% of the component return of the SPDR S&P 500 ETF Trust; (B) 15% of the component return of the iShares Russell 2000 ETF; (C) 15% of the component return of the iShares MSCI EAFE ETF; and (D) 15% of the component return of the iShares MSCI Emerging Markets ETF.

The component return of a basket component will be equal to:

final component price initial component price initial component price

where,

the initial component price is the fund closing price of such basket component on the pricing date, as set forth below; and

the final component price will be the fund closing price of such basket component on the calculation day. The initial component prices of the basket components are as follows: SPDR S&P 500 ETF Trust (\$241.35); iShares Russell 2000 ETF (\$141.14); iShares MSCI EAFE ETF (\$65.16); and iShares MSCI Emerging Markets ETF (\$41.20).
