Pre-payment of debt and disbursement of the second installment of financing with the China Development Bank

Rio de Janeiro, January 30, 2018 Petróleo Brasileiro SA Petrobras, further to the press release disclosed on December 5, 2017 and December 14, 2017, informs that it has made today the prepayment of the remaining balance of the financing agreement with China Development Bank contracted in 2009 in the amount of US\$ 2.8 billion, which would become due over the next 2 years.

Additionally, on January 26, 2018, the company made a US\$ 2 billion withdraw from the new financing agreement contracted with the bank at the end of 2017, which together with the first disbursement of US\$ 3 billion in December 2017, amount to the US\$ 5 billion financing agreement.

Petrobras will continue to evaluate new opportunities to extend debt maturities and reduce debt cost, in accordance with the deleveraging target set forth in its 2018-2022 Business and Management Plan.
