Novo Nordisk A/S – Share repurchase programme

On 2 February 2012 Novo Nordisk initiated a share repurchase programme in accordance with the provisions of the European Commission’s regulation no 2273/2003 of 22 December 2003, also referred to as the Safe Harbour rules.

Under the programme Novo Nordisk will repurchase B shares for an amount up to DKK 2.5 billion in the period from 2 February 2012 to 25 April 2012.

Since the announcement as of 13 February 2012, the following transactions have been made under the programme:

With the transactions stated above, Novo Nordisk owns a total of 25,684,235 treasury shares, corresponding to 4.4% of the share capital. The total amount of shares in the company is 580,000,000 including treasury shares.

Novo Nordisk expects to repurchase B shares worth DKK 12.0 billion during a 12 month period beginning 2 February 2012. As of 17 February 2012, Novo Nordisk has repurchased a total of 711,000 B shares equal to a transaction value of DKK 535,383,791.
