Novo Nordisk A/S – Share repurchase programme

On 9 August 2012 Novo Nordisk initiated a share repurchase programme in accordance with the provisions of the European Commission's regulation no 2273/2003 of 22 December 2003, also referred to as the Safe Harbour rules.

Under the programme Novo Nordisk will repurchase B shares for an amount up to DKK 2.0 billion in the period from 9 August 2012 to 29 October 2012.

Since the announcement as of 9 August 2012, the following transactions have been made under the programme:

Transactions related to Novo Nordisk's incentive programmes have resulted in a net sale by Novo Nordisk of 126,658 B shares in the period from 9 August 2012 to 17 August 2012. The shares in these transactions were not part of the Safe Harbour repurchase programme.

With the transactions stated above, Novo Nordisk owns a total of 15,308,619 treasury shares, corresponding to 2.7% of the share capital. The total amount of shares in the company is 560,000,000 including treasury shares.

Novo Nordisk expects to repurchase B shares worth DKK 12.0 billion during a 12 month period beginning 2 February 2012. As of 17 August 2012, Novo Nordisk has repurchased a total of 10,574,758 B shares equal to a transaction value of DKK 8,698,209,615.

The company also has leading positions within haemophilia care, growth hormone therapy and hormone replacement therapy. Headquartered in Denmark, Novo Nordisk employs approximately 33,300 employees in 75 countries, and markets its products in more than 190 countries.
