- (2) Consists of shares of common stock that the reporting person elected to receive in lieu of a portion of his annual cash retainer for serving as a director during calendar year 2010.
- (3) Includes 30,145 RSUs that may be settled only for shares of common stock. RSUs vest one year after the grant date and, on the settlement date, are convertible into shares of common stock on a one-for-one basis. The settlement date is six months after the reporting person ceases to be a director of Sara Lee.
