- (1) The Board of Directors approved the grant on September 5, 2013. The restricted stock units vest in four equal annual installments. Due to an administrative error in the calculation of the restricted stock units awarded on 9/5/13, the number of restricted stock units reported in the Form 4 filed on 9/9/13 was incorrect.
