(1) The Reporting Person was granted 49,056 shares of Restricted Common Stock under the 2006 Stock-Based Compensation Plan. 26,783 shares vest over a three year period as follows: 8,928 shares on January 16, 2010 and 2011 and 8,927 shares on January 16, 2012. The final 22,273 shares vest on January 16, 2012 based on the Company's Total Shareholder Return versus a defined peer group of companies, with the final number of performance based vested shares varying from 0 to 200% of 22,273.
