- (1) The Reporting Person was granted 99,276 shares of Restricted Common Stock under the 2013 Stock-Based Compensation Plan. 32,490 time-vested restricted shares vest over a three year period as follows: 10,830 time-vested restricted shares on February 28, 2018, 2019 and 2020, respectively. 34,296 performance-based restricted shares vest on February 28, 2020 based on the Company's Total Shareholder Return versus a defined peer group of companies, with the final number of performance-based vested shares varying from 0 to 200% of 34,296. 32,490 performance-based restricted shares vest on February 28, 2020 based on the Return on Invested Capital achieved by the Company compared to the ROIC target varying from 0 to 200% of 32,490.
