Ownership Breakdown: Lawrence J. Goldstein beneficially owns directly 1,991,275 shares in his name and 2,500 shares in the name of Lawrence J. Goldstein, IRA. As President of SMP Asset Management, LLC, which is General Partner of Santa Monica Partners, L.P., and (1) of Santa Monica Partners Asset Management, LLC, which is a General Partner of Santa Monica Partners II, L.P., Mr. Goldstein beneficially owns indirectly 673,000 shares and 28,709 shares, respectively. Mr. Goldstein contributed 3,000 shares to the Barbara J. & Lawrence J. Goldstein Do Good Foundation, Inc. Mr. Goldstein has beneficial ownership but not record ownership of these shares.
