(a) Amount Beneficially Owned:

As of the date of this filing, Integrated Core Strategies (US) LLC, a Delaware limited liability company ("Integrated Core Strategies") holds warrants ("Warrants") to purchase 975,575 shares of Common Stock and is thus the beneficial owner of 975,575 shares of the Company's Common Stock. Each Warrant entitles the holder to purchase one share of the Company's Common Stock at a price of \$6.00 per share. The Warrants will expire on October 4, 2011, unless redeemed earlier. In addition, as of the date of this filing, Millenco LLC, a Delaware limited liability company ("Millenco"), is the beneficial owner of 542,400 shares of the Company's Common Stock.

Millennium Management LLC, a Delaware limited liability company ("Millennium Management"), is the general partner of the managing member of Integrated Core Strategies, and may be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies. Millennium Management is also the manager of Millenco, and may also be deemed to have shared voting control and investment discretion over securities owned by Millenco. Israel A. Englander ("Mr. Englander") is the managing member of Millennium Management. Consequently, Mr. Englander may be deemed to have shared voting control and investment discretion over securities beneficially owned by Integrated Core Strategies and Millenco. The foregoing should not be construed in and of itself as an admission by Millennium Management or Mr. Englander as to beneficial ownership of the securities owned by Integrated Core Strategies and/or Millenco.

(b) Percent of Class:

Millennium Management and Mr. Englander may be deemed to beneficially own 1,517,975 shares or 13.2% of the Company's Common Stock (see Item 4(a) above), which percentage was calculated based on 10,548,932 shares of Common Stock outstanding as of January 2, 2009, as per the Company prospectus dated January 2, 2009.
