(1) These shares of common stock were granted as of September 1, 2005 pursuant to an employment agreement (the "Employment Agreement") between the reporting person and the Issuer dated June 29, 2005 and under the Overseas Shipholding Group, Inc. 2004 Stock Incentive Plan (the "2004 Plan") and are subject to vesting restrictions. The reporting person becomes vested in one fourth of such shares on each of the first, second, third and fourth anniversaries of the date of grant.

(2) The option to purchase 10,688 shares of common stock was granted as of September 1, 2005 pursuant to the Employment Agreement and under the 2004 Plan and will become exercisable as to one third of such shares on each of the first, second and third anniversaries of the date of grant.
