- Reports a grant of 6,068 time-based restricted stock units awarded on May 8, 2014, which represents 50% of Mr. Rickertsen's Annual Director Fee for the 3rd & 4th quarters of 2014 calculated as follows (\$75,000 annual fee divided by 4 quarters = \$18,750 per Qtr.;
- (1) \$18,750 * 2 Qtrs = \$37,500 divided by 50% = \$18,750 @ FMV on 5/8/14 of \$3.09 = 6,068 shares). Such award shall vest as Common Stock as follows: 50% - September 30, 2014 and the remaining 50% on December 31, 2014. The award is subject to partial or full acceleration or cancellation upon certain terminations of employment.
 - (2) Reports the purchase of 20,000 shares on the open market.
