On May 22, 2013, Guaranty Federal Bancshares, Inc. (the “Company”) held its Annual Meeting of Stockholders (the “Meeting”). At the Meeting, stockholders considered the election of directors, the Company’s executive compensation practices and the ratification of the appointment of the Company’s independent registered public accountants. Of the shares of common stock outstanding as of the record date for the Meeting, 79.0% were present in person or by proxy.
