Performance shares vest one-third on the attainment of 10%, 20% and 30% stock appreciation (which must be maintained for a minimum of three consecutive trading days) from the grant date closing price of \$1.43 per share. Vested shares will be distributed on the third anniversary of the grant date.
 - (2) Includes shares acquired pursuant to dividend reinvestment since Mr. Baert's last Form 4 was filed as well as dividend equivalents earned with respect to the vested performance shares.
