(1) 6,057 shares were withheld by HP to satisfy tax withholding on vesting of restricted stock units ("RSUs").

(2) Each RSU represents a contingent right to receive one share of HP common stock.

(3) On 12/7/2018, the reporting person was granted 69,778 RSUs, one-third of which vest annually over three years on the anniversary of the grant date. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock.

On 12/7/2018, the reporting person was granted 96,210 Performance Adjusted Restricted Stock Units ("PARSUs"), 50% of which will be earned on each of 12/7/2020 and 12/7/2021 subject to certain relative total stockholder return conditions being met as of those dates, and

(4) 50% of which will be earned on each of 12/7/2019, 12/7/2020 and 12/7/2021 subject to certain earnings per share conditions being met as of those dates. A portion of the earned units will vest on each of 12/7/2020 and 12/7/2021. Dividend equivalent rights accrue with respect to these PARSUs when and as dividends are paid on HP common stock.

- (5) On 12/7/2017, the reporting person was granted 35,765 RSUs, 11,921 of which vested on 12/7/2018, 11,922 of which are scheduled to vest on 12/7/2019, and 11,922 of which are scheduled to vest on 12/7/2020. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The number of derivative securities in column 5 includes 293 vested dividend equivalent rights.
