 - (2) Convertible on a 1-for-1 basis.
 - (3) Each performance unit is settled 100% in Vulcan common stock after deducting the amount of taxes due.
 - (4) In accordance with the terms of Vulcan's Deferred Compensation Plan and instructions previously provided by the reporting person pursuant thereto, each share of phantom stock will settle for a share of Vulcan common stock in January 2020.
