The restricted stock units were granted under the Santander Consumer USA Holdings Inc. Omnibus Incentive Plan. The restricted stock unit award includes a total of 14,565 shares, 20% of which vested at grant on April 10, 2015 and were settled in shares of common stock.

(1) The remaining 80% will vest in equal installments on each of April 10, 2016, April 10, 2017 and April 10, 2018. After the shares subject to the restricted stock units vest and are settled, they will remain subject to transfer and sale restrictions for a period of one year.
